## PRESTEIGNE AND NORTON TOWN COUNCIL

#### **CLERK'S REPORT**

#### **APRIL 2022**

#### 1. INFORMATION -

Community Group Fair: Postponed. May take place in the Autumn.

2. FINANCE – Internal Audit report issued separately.

#### 3. HIGHWAYS ETC -

- a) Hereford Street One Way: Issue with No Entry Signs: Signs were not lit at the start of the trial. Safe Routes Officer chasing up street lighting re. electric connection. However the officers have checked and made the following reply Street Lighting have advised further work to try to solve the electrical problem on the no entry signs is currently scheduled for next month. I have also asked them to look at the no entry signs on Broadaxe Lane, as the lights have stopped working (or are intermittent) on both.
- b) Parking Spaces opposite Farmer's Arms, Hereford Street: As requested the removal of the spaces was again submitted to PCC. The reply was as follows there is unlikely to be a parking review in Presteigne in the near future, so they will have to remain as they are. I am aware of the Town Councils views, but these weren't supported by the Local Member at the time, and significant objections to their removal from the consultation were also received. This was the democratic reason that they remained.
- c) Presteigne Roundabouts: As requested I have asked about plant costs over the coming year and have received the following reply 'We are not planning on purchasing more plants/seeds if we do they will be included in the quoted cost.'

  The full work plan is attached to this report.
- **4. NORTON** Community Speedwatch training took place at the end of March.

# 5. SITES AND BUILDINGS -

- a) Wilson Terrace Play Area: PCC have agreed that when they replace the swing seat (removed during covid) they will do so with a toddler seat.
- b) Insurance Requirements, Use of Barn/Meadow: As things have now settled down re the use of the new barn for classes of various types the question of insurance has arisen now users are filling in the full use form. For many the cost of having a public liability policy means that running classes is out of the question and I am seeking the Council's views on having a separate form for users of this type and recommending insurance rather than insisting (as with larger events). I have sought the views of our insurer on this (they asked for the insurance condition originally) but it would help to have the Council's views. I hope to have a reply from the insurers before our meeting.

#### 6. TOWN COUNCIL SURGERY -

a) Area outside Primary School: Has been swept and oak tree attended to. Resident informed. Thanks to PCC for doing this.



# Transforming Presteigne Roundabouts into perennial Wildflower Areas

# During 2022 between April and November we will:

- 1. Continue to remove any re-emerging unwanted plants e.g. docks, thistles, nettles (that will out-compete the finer wildflowers). Due to removing grass clippings over the past two years, the spring grass growth on both roundabouts is low so no early cut will take place.
- 2. Supplement the wildflowers with a further 10 plants in each roundabout (all of local provenance). These will be watered if rainfall is low.
- 3. Deadhead daffodils then cut back and remove this foliage ready for the spring/summer growing season (May, June and July).
- 4. After the flowers have bloomed we will cut and remove the long grass. We will need somewhere locally to put these clippings are we able to liaise with the council contractors so they can pick the roundabout clippings up when they pick up the verge clippings?
- 5. Collect seeds in July/August from St Andrew's churchyard. These will be sown on the roundabouts.
- 6. Carry out one further cut in October so the grass is short and neat all through the winter.

As in previous years this proposal is based on the current contractors continuing to cut the 3m edge around each roundabout at their normal frequency. Last year they didn't do this and it led to the roundabouts looking quite neglected. We have not sown wildflowers along the 3m edge as we were told the council would be keeping it short. If this edge is left to grow long, as the roundabouts are flat, the inner area with wildflowers will be obscured. For the flowers to be noticeable in 2022 the 3m edge will need to be kept short.
