She originally joined the council as she wished to put something back into the local community, and over time has worked on numerous community projects. She has two children and works as the Chief Officer for a local charitable organisation in the private care sector. She has particular interests in facilities for children, affordable housing, the community and financial issues.

She is presently an LEA Governor of Presteigne Primary School and Newtown High School, representing the interests of the John Beddoes Campus.

In January 2014 Beverley resurrected Presteigne Carnival which ceased almost 20 years before, it turned out to be a huge success and has continued as a wonderful annual community event. Happy that the Carnival was once again established Beverley relinquished her role on the committee.

Beverley is qualified to Level 5 in NVQ's and Level 3 in the Association of Accounting Technicians. She considers herself to be a hardworking, enthusiastic and approachable Councillor.

In May 2017 Beverley was elected as County Councillor for Presteigne and Norton. During the term of office, she was Chairman of Powys County Council.

Rose grew up in Presteigne and attended John Beddoes, later followed by a degree in silversmithing and jewellery at London Metropolitan University. Presteigne has a great sense of community and she is keen to bring people together to work to protect our vital services and organisations. Rose has run her own business in Presteigne for the last 12 years. She has been involved in a range of community groups, including the carnival, fireworks and Presteigne Players, Rainbows, Presteigne and Norton Community Trust and Sheep Music which she organised in 2009. Her last five years on the council have seen her help to focus the council on the environmental issues that we face and establish a Climate Action Group, a Tree Group, which has planted a small woodland and arranged events to raise awareness, and overseen the successful grant bid for a new nature reserve in Presteigne. She is looking forward to continuing to develop the Council's response to the Climate and Ecological Crisis.

#### **CLLR. RORY BENNETT (PRESTEIGNE WARD)**

Rory was born and bred in Presteigne, leaving only to study Countryside Management at university. He has always been heavily involved with the community, and most recently has been a key organiser of both Presteigne Carnival & Sheep Music. Presteigne is not only his home, but also his workplace. He was very grateful to have been given the chance to play his part on the town council, and to making a difference to our community.

#### CLLR. DEBORAH DAVIES (PRESTEIGNE WARD)

Debbie says - I have lived in Presteigne for over 40 years, and during that time, have been involved in the Playgroup Committee, PTA, John Beddoes Governors, the Scout Group, and am currently Chair of Presteigne Carnival Committee and Vice President of Chatterbrook W.I. I now have young grandchildren growing up in the community and am keen to ensure that Presteigne and Norton community continues to thrive and be a place that I am proud for my grandchildren to grow up in.

#### **CLLR. COLIN KIRKBY MBE (PRESTEIGNE WARD)**

Cllr. Kirkby has been a Town Councillor since 1987 and is now the longest serving member. He has been Mayor 7 times. He has been responsible for a number of hands on projects during that time including the setting up of the Withy Beds nature reserve; the purchase of Lower Went's Meadow - three acres of ground for recreational use by the river Lugg on which the allotments were added; purchase of Silia Woods an important arboretum and backdrop to the community, which was gifted to the Woodland Trust; the setting up and running for 20 years of the Presteigne recycling centre which won 6 National Awards and put over £40,000 back into the community; obtaining grants for and leading the volunteers in the development of the Upper Went's Meadow after purchase by the Town Council, which included the refurbishment of an old barn, a community physic garden, footpath infrastructure, community orchards and the building of a skateboard and mountain bike track. He chaired the steering group and helped raise funding for the Welsh Assembly Funded Zero Waste Project which ran for three years from 2010 and achieved the highest recycling rate at that time in the UK of 74%. More recently he acquired an area of ground on the side of the Warden which has been dedicated to Cllr Eddie Taylor MBE and is managed as a hibernaculum. This was followed in 2013 by persuading Welsh Water to gift the old reservoir on the Warden to the Town. He continues to Chair the subcommittee which looks after the Went's Meadow which he has done since the formal opening in 2001. He is currently leading a proposal to secure the future of the Assembly Rooms as an Arts and Culture Centre for Presteigne and Norton retaining the building for the Library and MBA.

### DARK SKIES PROJECT

In the UK today less than 10% of the population can enjoy a truly dark sky. Light pollution affects health, wildlife and energy consumption.

Following an approach to the Town Council from a local resident the Council has been working with the resident, a lighting designer and the County Council to investigate the possibility of applying for dark sky status for Presteigne and Norton.

The benefits of dark skies are -

To preserve the environment and protect the natural behaviour of nocturnal wildlife.

To enjoy the full experience of our night skies and to see our stars.

To appreciate the character and beauty of the natural landscape.

To protect our health and well-being.

Currently the street lighting in Norton has been upgraded to dark skies compatible lighting and work is ongoing to the Presteigne lights.

Work on a formal application to the International Dark Skies Association is ongoing and the intention is to submit an application towards the end of the Summer of 2022.



## COMMUNITY ULTRA FAST BROADBAND PROJECT

In the February 2022 the Council, working with Broadway Partners, a rural internet provider, sent letters to all properties in its area to gauge interest in bringing ultra-fast (min 100mb) fibre to the premises broadband to Presteigne and Norton and surrounding rural properties.

The target of 20% of properties was reached in July 2022 and a funding application will now be submitted to UK Government (subject to the agreement of the Broadway Partners Board). Once submitted applications take an average of four months to determine although it can be more.

#### **FAQ** on the Project

#### I'm in a contract with another provider so I can't register can I?

Yes you can register. You are not committed. Registration will help the scheme get started and will help us enormously. The project will take some time and it is likely your contract will have ended before we are ready to ask you if you want to commit to connecting your property.

#### I have a good speed now. Why would registration benefit me?

Few if any properties in the area have a fibre to the premises connection with speeds starting at 100mbps. Some will have fibre from the cabinet but this is likely to have a max speed of around 70mbps. As more and more use if made of the internet ever faster speeds will be needed. This connection will help future proof your connection into the future and will also make your property more attractive to buyers should you sell.

## What will my commitment be if the project goes ahead and I decide to connect my property?


You will need to commit your 'connection voucher' from UK government. This can only be claimed by an official provider such as Broadway Partners, it cannot be claimed by individuals. Your connection will then be free of charge.

Once connected you will be in a contract for a minimum 12 month period. The minimum speed of 100 mbps currently costs £19.99 per month. After this you are free to leave if you

wish but we very much hope you will be pleased with connection and continue. £19.99 is a very competitive price.

#### Would waiting for BT be a better idea?

There is no current evidence that BT are interested in extending even their existing superfast broadband service to those properties in our area that are not currently connected.



### SEWAGE SYSTEM UPGRADE

A major project which came to fruition during the year was the Welsh Water upgrade of both Norton and Presteigne sewage treatment plants. In 2015 the TC held its first meeting with Welsh Water to express concern over capacity issues which were preventing housing development. Over the following years the Town Council has pushed Welsh Water to include the money for development in their business plan for 2020-25 and continued to press that it should happen early in that period. However whilst the upgrade has happened as hoped for, there is now an issue with the phosphate levels in the River Lugg and the necessary stripping plant for the water discharge has yet to be installed.

## REFURBISHMENT OF TOWN BENCHES AND ADOPT A BENCH

During the year, a local resident, John Kendall approached the Town Council with an offer to refurbish the Town's benches. Cllr Kirkby liaised with the resident and Nick Close undertook the work to refurbish the benches and provided a new bench at the end of Station Road. The Town Council was extremely grateful on behalf of the Town for John's generosity. John was a previous Town Mayor in 2011-12. Following this the Town Council launched an Adopt-a-bench appeal for residents to look after a bench and keep it tidy. If you'd like to help please contact the Clerk.

### **COMMUNITY DONATIONS**

The Council also received a generous donation of £1000 from an individual towards play equipment. This was used towards the new roundabout in the Wilson Terrace play area.

## **COMMUNITY BARN**

A big thank you to Sheep Music and in particular Owen Rimington who having been responsible for the design and building of the new barn on Went's Meadow was finally able post covid to have the panel in the roof filled in laser cut steel panels of his own design and which tell many stories including the building of the barn. The barn proved extremely useful during the pandemic as a safe open air venue to meet when the regulations allowed with numerous classes and groups able to use the space once outdoor activities where permitted. Classes included tai chi, dance, Women's Institute meetings, fitness, flower arranging and many more.

### **CREATION OF NATURE RESERVE**

Last year the Council wrote to local landowners with the hope of finding a suitable field close to the town to create a new woodland nature reserve to become part of the National Forest of Wales and to create a designated place for nature on the edge of town. This is fully funded achieved with the help of the Heritage Lottery Fund and The Welsh Government. A suitable field was found and with the help and expertise of The Woodland Trust, Natural Resources Wales, CADW, Radnorshire Wildlife Trust and many local experts and enthusiasts a plan was made.

The grant fund encourages a mosaic of mixed habitats and the proposal is to create areas of open grassland, wild-flower meadow, ponds, native tree woodland as well as maintaining the currently registered area of Historic Parkland Garden vista with more of the specimen arboretum trees planted to replace the ones that have been lost. The grassland will be mown annually and encouraged over time to become a wild-flower meadow. A wide native species hedge along the field boundary and groups of native tree planting will cover the rest of the field creating corridors for wildlife and links with surrounding woodland, bringing part of the National Forest into the town.

This project will help Presteigne address climate change by storing carbon and will be managed as a nature reserve with help from members of the community to create and maintain it.

By the end of March 2023 the hope is to have planted the hedge and woodland areas, created the ponds, made new access that is suitable for people with disabilities with a wide hard path suitable for wheelchair users and started to improve the grassland areas to become wildflower meadow.





### **TOWN WIFI**

In July 2021 the Town Council was approached by the County Council to establish its interest in providing free wifi in the town centre.

Members met in August to consider the suggestion and it was agreed that the Council should be part of the project. The Clerk and Cllr. Ruby held meetings with the County Council and talked informally to local shopkeepers etc. about siting a unit on their premises.

In early September a grant application was submitted to Welsh Government and shortly after it was confirmed that the money had been awarded.

Work then started on producing a tender specification for the installation (County Council) and on confirming sites in the town.

Thanks is due to the following for agreeing to site the units –

The Salty Dog

No. 46 Wine Bar

The Old School (Presteigne Youth Project)

The Royal Oak

Permission to site two units on the Assembly Rooms is still awaited from the County Council but the first four units are installed and in use.

In addition to providing the free wifi the system will also provide visitor data (numbers/length of stay etc) which can be supplied to businesses and used to provide supporting information for grant applications etc.
