SYNOPSIS OF ACTIVITIES AND FUNCTIONS

The Chamber runs fund raising activities each year with the dual purpose of raising funds for the Chamber's activities whilst at the same time providing community events for the general benefit of the Town and social events for the benefit of members and their friends. There have been Cheese and Wine evenings, Woodland Barbeques, Magic Lantern Evenings, Fun Days, a Bingo evening and Street Parties. However we are always looking for and welcome new ideas.

The Chamber also supports events organised by other organisations or individuals in the Town, for example it has made donations to the Firework Display and gives practical support in connection with the Vintage Sports Car Club Welsh Trial weekend each October.

A recent undertaking has been to take over and run the Recycling Centre, to prevent it being closed by Powys County Council. This facility is very well used by the community and would be sorely missed if it was closed. The Chamber receives payments from Powys County Council based on the amount of recycling processed, and this is a valuable source of income for the Chamber.

At Christmas, The Chamber runs the "Presteigne Llanandras Christmas Fair" both for the benefit of the town, and to encourage a welcoming atmosphere in the High Street that will engender loyalty in potential shoppers throughout the year. In recent years it has been run on a Friday evenings with all the shops staying open to promote their businesses and it has proved very popular.

The Chamber has for many years been responsible for producing promotional literature and leaflets for the Town. It was the instigator and founding member of the Presteigne Tourism Project, which produces a Town Tourism Leaflet and a Town Trail each year and is responsible for the creation and running of the Presteigne and Norton Website. This facility has been set up to promote Presteigne and Norton and the surrounding areas from a Tourist point of view. This website is also seen as an increasingly useful source of information for local people. It also offers very reasonably priced advertising for local accommodation providers, restaurants, and businesses.

The Chamber involves itself in and represents the views of members with respect to issues that are felt important. Recent issues have been car parking charges, town signage, refuse disposal and traffic movement issues. The Chamber provides a forum where issues of concern to members can be discussed. As a member of The Chamber, you are able to voice any concerns you may have or have a say in decisions that may affect your business.

As The Chamber is a recognised body, it is able to communicate officially with the Presteigne and Norton Town Council, Powys County Council, and other Local and National Government bodies in connection with issues of concern to members, raising it's voice above local level.

CONSTITUTION OF PRESTEIGNE CHAMBER OF TRADE, COMMERCE A ND INDUSTRY (FOUNDED MARCH 1989, REVISED APRIL 2014, JUNE 2016)

1) NAME: PRESTEIGNE CHAMBER OF TRADE, COMMERCE AND INDUSTRY

2) AIM: To promote and safeguard the trading and commercial interests of Presteigne and to encourage new trade for the benefit of the area.

3) MEMBERSHIP: Shall be open to persons engaged in trade, commerce and industry and any other persons interested in contributing to Presteigne Chamber of Trade, Commerce and Industry.

4) OFFICERS: To be elected each year at the Annual General Meeting.

5) SUBSCRIPTIONS: To be reviewed annually at the Annual General Meeting. To be payable by 1_{st} May each year. The Presteigne Chamber of Trade, Commerce and Industry reserves the right to remove members who have not paid their subscription fees, from the register.

6) NEW MEMBERS: New members do not need to be elected. Anyone interested in joining may attend meetings and will become members on payment of subscription fees.

7) ANNUAL GENERAL MEETINGS: Shall be held on the first Monday in April each year.

8) CHEQUES: To be signed by two of the three officers, i.e. Chairman, Treasurer or Secretary.

9) CONSTITUTION: Any changes or amendments shall be made at the Annual General Meeting or at an Extraordinary General Meeting called for that purpose.

10) HONORARIUM FOR SECRETARY: Shall be reviewed annually and agreed by members.

11) QUORUM: A minimum of six members must be present if a vote has to be taken

12) WINDING UP: In the event the Chamber ceases to operate any funds it holds following payment of any outstanding debts would be handed to the Town Council for distribution at the discretion of the Town Council, to appropriate community groups for the benefit of the community.
