## MIN 3347 PLANNING

#### Planning Applications:

P/2017/0788, Grid Ref: 331002.48/264119.19 for Reserved matters application in respect of outline planning permission P/2014/0049 for the erection of 2 dwellings and creation of shared access at Plots 2 & 3 Slough Road, Presteigne. Cllr. Wilding reminded Members of the letter of objection submitted to the Council concerning a legal covenant. Resolved no objections to the above application. Additional comment - the Council understood that there was a possible legal issue which had been already brought to the attention of the County Council by the affected resident. It was noted that this issue was not a planning consideration.

P/2017/0790, Grid Ref: 331025.14/264128.96 for Full: Erection of two storey dwelling and associated works at Plot 1 Silia Meadow Slough Road, Presteigne. Resolved no objections be raised in principle but two concerns were raised. These were - the site is very close to the junction and so the requirements of the Highways Section should be included in any permission plus concerns about the height of the proposed dwelling in relation to its surroundings.

P2017 0204, Grid Ref: 329460.97 266767.82 for Full - Repair and renovation of the west wing of Norton Manor and Change of Use from Hotel to Dwelling (retrospective)at West Wing Norton Manor Hotel Norton Manor Park Norton (amended particulars). Resolved to fully support the application.

## MIN 3348 CORRESPONDENCE/GENERAL ITEMS

- (1) Invitation to Palace of Westminster, Chris Davies MP: Cllrs. Ruby and Edwards would be interested. The Clerk was asked to provide contact details so a visit could be arranged.
- (2) Sewerage Services, Welsh Water: Reply re improvements in Presteigne and Norton (as previously circulated): Noted.
- (3) Report on Welsh Government Meeting, 20th July 2017: Noted.
- (4) Cutting of Footpath, Folly Wood-Silia Meadow-Slough Road: Cllr. Baynham reported that this had been done and so was no longer a pressing issue. The matter would be reviewed in the future if necessary.
- (5) Powys Well Being Plan Further Survey: Cllr. Ruby raised a number of points and agreed to produce a summary for the Clerk to submit.

## MIN 3349 TOWN COUNCIL SURGERY

(1) Report on August Surgery: Cllrs. Baynham and Ruby had attended.

A number of items had been raised -

- Yellow lines PCC have re-painted the yellow lines and have put them by the dropped kerb outside the Dukes and extended them outside 34 Hereford Street. This was new. Clerk to review recent traffic order.
- 40 Hereford Street, leaving recycling bins out all week: Cllr. Baynham had arranged for a letter to be sent.
- 2 pine trees on the edge of secondary school playing fields blowing pine needles into the garden of Clatterbrune: No action. Not a Council issue.
- Speeding down Greenfield Road and speeding in general in Presteigne: Clerk to report to PCSO Anna Bowen and ask for action.
- Footpath behind The Paddocks, rubbish, rubble, dumped cars: This was on private property. Clerk to write polite <u>letter asking</u> if the area could be tidied.
- Trees overhanging Clatterbrune: Cllr. Baynham would check and if necessary report to the Clerk so a letter could be written.
- Memorial Hall car park huge hole in the middle of the car park: Ownership to be checked and reported for repair.
- Parking in Pound Lane problem for residents, would like a parking permit for houses only: Not currently possible under County Council policy.
- Norton Church 10th Sept. Harvest Service & December Christmas Service. Enquiry on possible closure: Noted.
