CONCERNS ABOUT PROPOSED CHANGES TO POWYS' LOCAL DEVELOPMENT PLAN (LDP) AFFECTING PRESTEIGNE & SURROUNDING COUNTRYSIDE

At a very late stage in the proceedings, Powys County Council have proposed Further Focussed Changes (FFCs) to the Local Development Plan (LDP) for Powys.

One FFC specifically affects the Kaye's site in Presteigne concerning the presumption of approval for retail planning applications (e.g. supermarket etc) which could have serious implications for our High Street.

Another proposed FFC concerns the designation of over a third of Powys (outside the National Park) as Local Search Areas within which there will be presumption of approval of planning applications for large wind and solar energy farms in Powys.

Whatever your views on the desirability of having a supermarket in Presteigne, or on the expansion of Renewable Energy (RE) sites in Powys, these FFCs do raise concerns about the 'nodding through' of applications for the building of such facilities, essentially avoiding local consultation.

PCC have brought in these proposals with barely-advertised consultation procedures undertaken in the shortest possible time. Those few who heard about them were able to make written 'representations' before a November 2016 deadline, and/or register their right to make verbal representations at public hearings starting in late March.

Much, if not all of the above, may come as news to you, and the legal documents concerned may well prove impenetrable to the casual eye. However we would urge anyone concerned about these matters to make a small effort and go to Powys County Council's website to get a sense of what's at stake:

FFC 13, section 3.3.10 and FFC 72, section 4.7.7.A are the crucial sections, but please note that the time for personal representations has now passed.

Finally, you may like to know that there is a **PUBLIC DEMONSTRATION** planned for **9.30am next Thursday the 23**rd **February at County Hall in Llandrindod** where the specific issue of the Renewable Energy FFCs are to be debated.
