# Cyngor Tref Llanandras a Norton Presteigne & Norton Town Council NEWS from the meeting held in December 2024

**Planning applications:** The following planning applications were discussed – 24/1682/TRE Grid Ref: E: 331565 N: 264492. Proposal: Works to mature Beech tree in a conservation area. Location: St Andrews Church, Broad Street, Presteigne LD8 2AF: Resolved to request that the applicant obtain a professional opinion on the need to remove the tree as none had been included with the application.

**Planning Decisions:** The following decisions were noted: -24/1471/TRE Craftsman's Mews, Presteigne: Approval. 24/1482/TRE Radnorshire Arms Hotel, Presteigne: Approval. 24/0338/FUL Holiday Chalet at Harp Meadow, Presteigne: Approval. 24/1504/TRE The Rectory, St. David's Street, Presteigne: Approval. 24/1349/TRE 1 Wherby Cottage, Presteigne: Approval.

Leisure Centre Future: Many residents will be aware of the recent report issued by the County Council which placed the future of the Leisure Centre under threat. The review of Leisure Centres has been pushed on to Summer time but the threat has not gone away. Please watch out for any updates in the press or on the Town Council website and facebook pages and be ready to comment to support the retention of the Leisure Centre when the consultation goes live. In the meantime please be aware that the use of the centre is monitored and the figures will be part of the County Council's considerations - please try to support your local centre.

**Fold Farm DMMO Application:** Cllr. Kirkby reported that the Officer expected to work on the draft report over the Christmas period with a view to issuing it in early January.

**Presteigne Memorial Hall Update:** It was confirmed that the formal transfer had now taken place and the Committee was now hoping to open for early February. It was agreed that the Clerk write and thank the Committee Members for all their efforts. It was also agreed to release the grant awarded for 2024-25 and which had been held pending the transfer.

**Meadows:** Update - Bike Track: Cllr. Owens reported that he had been in touch with the parents and was now waiting to hear from them on their plans.

Update - café bar/storage: Cllr. Kirkby reported that he had now submitted the planning application and the grant application to the lottery.

Possible New projects for 2025/26. Potential projects put forward were:

Meadow Access Paths (match funding); Meadow Bar/ Storage; New Website; Christmas Lighting; Dark Skies Project; East Radnor Leisure Centre. These projects would be considered fully at the budget setting meeting on 15th January.

**Conclusion of External Audit for 2023-24:** Members noted the conclusion of the audit. No matters requiring action had been raised.

**Website Advert Renewals:** Letters/emails had gone out to all the current advertisers. If any business or accommodation provider wishes to have an advert on the town site please get in touch. Cost currently 50p per week.

**Car Parking:** The Portfolio Holder had responded to the email from the Clerk citing loss of income as one of the main reasons for not allowing free parking for the first hour. Cllr. Kirkby felt that the statement over the loss of income was incorrect given the under use of the Shoppers Car Park in particular. The Clerk to reply to the Portfolio Holder stating that little income would be lost and again pressing for a first hour free. The Clerk also to ask whether community asset transfers would be considered as part of the new review.

Administration costs were agreed as  $\pounds$ 36,413 and the amount for the maintenance and running of Went's Meadow  $\pounds$ 14,515.

#### This produced a budget of £89,098. It was agreed to use £13,000 from free reserves and to set a precept requirement of £76,053.04. This would result in a precept of £56 per Band D property, the same as in 2024-25.

The full budget has been placed in the Council Accounts section of the Presteigne.org.uk website.

### **Review of Income:**

Noted that the review of the allotment rent was next due in late 2025 for implementation in March 2026.
